

IETM Satellite Meeting 2007 Seoul, Korea

SEOUL MEETING IN NUMBERS

The Seoul Satellite Meeting counted a total of 251 registered participants coming from 37 different countries or autonomous regions. From the total delegates 48 % came from Korea, 10 % from Europe and 42% outside Europe (excluding Korea).

FEEDBACK SUMMARY AND ANALYSIS

General

The predominant expectations of the meeting were "To network with both European and Korean artists/presenters" (approx. 2/3 of respondents), "To learn more about artistic collaboration between Asia and Europe" (approx. 1/3 of respondents) and "To learn about the context of European/Korean contemporary arts" (approx. 2/5 respondents). 90% of respondents found that their expectations were met extremely well, well enough or satisfactorily. The majority of participants (89%) believed that the goals of the meeting's theme had been met extremely well, well enough, or satisfactorily.

Comments of praise seem to focus on the diversity of the participants; the opportunity to learn about the current performing arts scene in both regions; the global network providing a broader view/the arts bringing the world closer together. Criticisms concern lack of depth in the sessions; lack of opportunity for discussion (in smaller groups)/informal networking; poor timekeeping; inaccessible venues.

Sessions and content

Session 4: Mobility and Collaboration was the most popular session, with approx. 2/5 (37%) respondents nominating it as the most interesting. The other sessions had roughly equal popularity (ranging from 7%-15%). The aspects of the sessions that seemed to appeal to most participants were: relevance to their specific field of work; the opportunity to learn about the current state of performing arts in Korea/the rest of the world; diversity/originality of information and issues. Participants stated that the session on Mobility and Collaboration was particularly successful as it is a topical issue of interest throughout the world, also that the content was of high quality with well-balanced topics and good questions from the participants.

Session 1: Performing Arts Management was the least popular session, with 1/4 respondents nominating it as the least interesting. This was followed by Session 6: Cultural Cities and Performing Arts and Session 2: Performing Arts Events & Management (17%, 13%). The reasons given for dissatisfaction were that the content was too general and not substantial enough, also that there wasn't enough time for questions and answers.

Suggestions to improve the sessions include, regarding the contents: more time for discussion between the participants; more practical themes and more concrete and realistic alternatives/plans for the arts; narrower themes. Regarding organisation: participants should have more opportunities to contribute; fewer speakers but more in-depth topics; moderators should play a more active role; better translators/timekeeping; an artist on every panel; more multimedia/info in the programme booklet.

Sessions on climate change and the arts, and lack of mobility within nation states were requested.

Other programmes and management

The sessions, the performances and the lunches/parties seem to be the most popular, but greater percentages of respondents didn't attend the National Museum trip or City Walk. 83% of respondents rated the facilities available as excellent, good or satisfactory. Suggested

improvements were: more accessible venues; more casual programme; more interactive sessions; more time to rest between day and evening programmes; earlier PR activity.

Future plans

Half of the respondents have concrete plans for activities arising from the meeting, including future collaborations, distribution of work in Europe/Korea, information exchange, using contacts for research/programming. Participants hope that KAMS might help by sharing meeting proceedings, networks, database, info regarding entry into international market, info on specific festivals, DVDs of Korean work.

82% of respondents would like IETM to continue to co-organise further meetings in Asia. 44% of the respondents who named a specific location suggested Korea. Suggestions for how the meeting should be organised include: a more casual programme; more in-depth exploration of topics; more participant discussion – workshop format; smaller group meetings; meeting more linked to a market/festival – including exhibitions/performances; specific suggestions about organisations to work with.

83% of respondents would like IETM to organise experiences in Korea again. Suggestions for format of these meetings include: smaller sessions with more choice and more time for discussions/more opportunity to meet the presenters; similar to this time; conference; lectures and symposia; seminars; forums. Suggestions for content include: practical info for international exchanges, current issues/successful cases in contemporary performing arts/performing arts development.

67% of Korean respondents intend to participate in future IETM meetings held outside of Korea.

4. What did you like the least about the satellite meeting in Seoul in general?

Korean responses

- The lack of depth in the contents
- Not enough in-depth discussion which failed to bring in urgent problems.

- o Some of the speeches were merely listing past experiences.
- Not enough time for an in-depth discussion.
- o Some of the speakers didn't seem to have prepared for the session enough.
- o The difference in the levels of the sessions.
- o The lack of programme for closer communication such as a small-group talk.
- Not enough opportunities for the floor to take part in the discussion

- Poor organisation of the event/venues

- o The time was not kept as scheduled.
- o Insufficient materials and information on the speeches.
- The loose atmosphere and badly organised traffic line.
- o The poor organisation gave me the impression that it was a perfunctory event.
- I wish it had been organised better.
- o I think the venue was too small and not proper for the occasion.

- Others

- o Not many Korean performing arts experts took part.
- The artistic and cultural programmes were not diverse enough.

International responses:

- It would have been better if all of the participants could have more time to freely exchange conversation.
- The fact that the meetings were always very formal. It would have been good to have a round table discussion, so there can be interaction and dialogue at a deeper level.

Why?

o Difficult to say, all were interesting in some way...

- Session 1)

- o It didn't meet my expectation.
- o The content was not substantial enough, and its approach was too general.
- o It would have been better if the session provided more European cases.
- o There was little that aroused my sympathy in the contents.
- The gap or difference between Korea and Europe seemed big, in terms of the cultural development.
- Too general and flat.
- o Too general.

- Session 2)

- The approach was too general.
- o I think we already have enough information on the western cases.
- o The links between the different speakers were not articulated as clearly as in other sessions.
- o For me it was too technical.
- o Too general and flat.
- Too general.

- Session 3)

- o Too general and flat.
- Session 5)
- It might have been difficult for those with little knowledge on the field to follow the session, especially when the materials and information on the speeches were not sufficient.
- The session was focused more on the speeches, and didn't leave much space for the Q&A session.

- Session 6)

- o The speeches were abstract and general, and the cases mentioned didn't sound substantial.
- The presentation on the Korean case was a bit superfluous, and didn't really fit for the session theme.
- \circ $\,$ Certain (parts of) presentations digressed from the session theme.

9. How could the contents of the sessions be improved?

- I think the sessions were interesting enough.
- I was content with the sessions.

- Regarding the contents

- o The contents of the sessions seem to lack in depth and substance.
- o The sessions did not present concrete alternatives or plans.
- o The sessions need a theme or agenda that can lead active discussions.
- The sessions need more practical themes that can be applied to the actual site of performing arts management.
- o A process-based presentation of the various European projects would have helped.
- We need to seek a solution based on the Korean context.
- o The contents of the sessions could be adjusted in advance.
- I doubt that some of the suggestions made by the participants can be adopted for the Korean performing arts sector which lack relevant professionals.
- o The organisers should select appropriate speakers with the right qualifications.
- o I wish there had been more discussion on shared issues or interests.
- I wish there had been more information on or a general introduction to the European performing arts sector.
- The sessions could offer more practical information with statistical data.
- o There was certain disparity between the broad theme and the case-focused presentations.
- The themes were too broad to bring out specific arguments.
- While several speakers alluded to the impact of climate change I think it would be highly relevant to include a session on the performing arts and climate change.
- o I would like to see a session on reasons for lack of mobility within nation states.

- Regarding the organisation of the sessions

- The speakers might need longer time for more substantial presentations.
- o The audience needs opportunities for their active involvement.
- The participants should keep their time.
- The organisers could provide channels and tools for more active exchanges with international participants.
- The organisers could distribute more concrete information or materials on the session presentations.
- At least one artist on each panel.
- Invite better translators. I believe there were many important points and meaning missing after the presentations have been translated.
- o More indepth discussion of topics instead of having too many speakers

10. (Question for Korean participants only) How could the organisation of the sessions be improved?

- There were too many speakers in each session.
- The speakers should keep their time for speeches.
- o Moderators should take more active roles.
- The organisers should come up with more innovative forms of meeting, other than onedirectional, lecture-like ones.
- o I'd prefer shorter speeches for more free discussion and opinion exchanges.
- Multi-media can be a good tool to attract the audience's concentration.
